

As the winter season and waves roll through in November, this means the holidays are right around the corner and so is the Vans Triple Crown of Surfing! Historically, surfers from Hawai'i have performed extremely well in the events, especially surfers like John John Florence, Andy Irons, and Sunny Garcia to name a few.

The HIC Pro Presented by Vans, a World Surfing League Qualifying Series 3,000 event takes place just before the Triple Crown and will qualify nine surfers from the Hawaii/Tahiti Nui region into the first two Triple Crown events - the Hawaiian Pro and Vans World Cup. This event allows local athletes to compete professionally right in their backyard! The HIC Pro takes place in Sunset Beach where WSL Hawaii/Tahiti Nui Regional front-runner Barron Mamiya, 17 years old, and remarkable North Shore surfers like Billy Kemper, Finn McGill, and defending event winner Mason Ho will compete in epic waves for points, qualification, and prize money. Hawai'i as we know is a mixing pot of many different cultures, and nearly 20 different countries from several continents are represented in the HIC Pro, including Argentina, Brazil, Chile, France, Indonesia, Japan, Morocco, New Zealand, Peru, South America, and Uruguay.

The North Shore of O'ahu is considered to be the surfing mecca of the world offering world-class waves for pro surfers to display their incredible skills, often drawing many spectators. Whether you're out in the water or watching from the beach, here are a few tips to enjoy the events this season to stay safe and have fun.

- · Show aloha: drive courteously, don't rush, and watch out for pedestrians.
- · Sun protection: even on overcast days: sunscreen, hat, sunglasses, plenty of water.
- \cdot Reusable bottles: water filling stations are available at all contest sites.
- · Binoculars: the beaches can get so crowded bring a pair to add to your experience if you're watching from afar.
- · Camera: capture the moment and maybe a selfie.
- · Beach chair: a towel or mat to sit on would be nice

to sit on as well.

- · Pay attention to road signs, warning, and driveways: nothing squashes a good time like a parking ticket or a towed vehicle. Follow the rules and the law. Don't stop on Kamehameha Highway to watch you may be towed, fined, or both. Also, don't leave valuables in your car.
- · Pick up trash: Take care of and respect the land. Malama ka 'aina. Clean up your area before you leave.
- · Listen to the lifeguards: their job is to keep you safe. In the winter, waves can double in size within an hour.
- · Use public transportation: avoid parking and traffic
- North Shore buses are Routes 52, 55, 88A. You can also park at Turtle Bay Resort and ride their hourly shuttles for a fee.
- · No smoking at state parks and beaches: discard cigarette butts in appropriate receptacles.

The Vans Triple Crown of Surfing kicks off with the Hawaiian Pro, followed by the Vans World Cup of Surfing, and wrapping up with the Billabong Pipe Masters. Good luck to all contestants! To all spectators: have fun, show aloha, and stay safe!

Congratulating And Recognizing Makuakai Rothman 2015 World Surf League Big Wave World Champion

Big Wave World Champion, Makuakai (Makua) Rothman was born and raised on the iconic North Shore of Oahu from humble beginnings where he started surfing at the age of two. Appropriately, Makuakai translates to father of the sea. For as long as he can remember, Makua felt a calling to the ocean where he has spent countless hours, surfing his way to numerous awards beginning in 1994 when he won the 1st Keiki Award for the Local Motion/MCD Surf into Summer Competition. He attributes his surfing ability in large part to his father, Eddie Rothman who shared his love of the sea with Makua and his two younger brothers Koa and Lono.

Makua was crowned the 2015 Big Wave World Champion in the World Surf League's first sanctioned Big Wave World Tour on February 28, 2015. He began surfing some of Hawaii's biggest waves, including Pipeline and Sunset Beach before the age of ten. At eight-years-old he surfed 12-foot Waimea waves and by the age of 13 he had emerged as one of Hawaii's most promising young surfers. At 18 he won the 2003 Billabong XXL Award for riding a 66-foot wave at Jaws on November 26, 2002, the largest wave known to be surfed anywhere in the world that winter.

In 2012 Makua began his journey in music, a passion he shares with his family of entertainers, grandmother Grace Costa and grandfather Robert Costa who always encouraged his love of music, keeping an ukulele ready at all times. He was taught by notable local entertainers including Israel Kamakawiwo'ole who encouraged Makua to sing for Hawaii and on behalf of the Hawaiian people, honoring where he came from and who he is as a Hawaiian. Makua released his first full-length album, Sound Wave in 2013 which debuted as the #1 Billboard World Album on iTunes and peaked as the #1 Billboard Reggae Album in December 2013. He is currently in the process of recording his second album, Keep Aloha.

Makua overcame various obstacles during his childhood including asthma which made surfing a difficult and dangerous pursuit. However, he always reminded himself that if he just kept on going things would work out. He has turned his struggles into a platform from which he encourages others to make


their mark in the world and always remember that tomorrow is another day. He is involved with various organizations such as Mauli Ola, a non-profit that provides opportunities for children with cystic fibrosis and works with any child with a genetic disorder. He is also involved with AccesSurf and Surfers Healing. Makua aspires to organize the Makua Rothman Foundation and establish an athletic facility for children and youth on the North Shore.

Makua Rothman is also a family man and takes great pride in instilling all he has learned through his many life experiences to his children: Thor, Hikianalia and Kaleoali'i with his fiancée Nalani Itomura.

Therefore, on behalf of the people of the City and County of Honolulu, the Honolulu City Council congratulates and recognizes Makuakai Rothman on being named the 2015 World Surf League Big Wave World Champion. Further, the Council extends its sincere appreciation for his many contributions and dedication to be an ambassador of Hawaii and advocate for his culture and wishes him continued success in all future endeavors.

Ways and Means Statewide Visits

Every two years, the Senate Ways and Means Committee (WAM) visits state facilities and priority projects around the state. Ways and Means is the committee that considers every bill relating to government spending that passes through the Senate. These bi-annual field trips allow committee members to meet with neighbor island agencies and community leaders to better understand the diverse needs throughout the state.

On Maui, we visited various schools, the Maui Community Correctional Center, Iao Valley State Park, a senior housing facility, a homeless and transition shelter facility, Maalaea Harbor, and members of the County Council.

Over three days and hundreds of miles of travelling around the Big Island, we visited the Ocean Thermal Energy Conversion (OTEC) facility, new, historic and off-the-grid school buildings, an amazing tilapia farm that is gearing up to produce millions of pounds of fresh fish, an agricultural coop in Waimea, a medical marijuana production facility, various state lands in Hilo, the Hawaii Community Correctional Center, Puna Geothermal Ventures, and a papaya farm.

Our Kauai visit included visits with more schools, the Moloaa Irrigation Coop, Kauai Island Utility Corporation, county officials, the harbors division, and a tiny homes test project.

These trips bring home the many needs faced throughout the state and challenge decision makers with prioritizing these needs. Each group and project seems very worthy when presented. In my opinion, it is important to remember the core responsibilities of state government and to be careful before taking on new obligations.

The most shocking experience of these recent WAM trips was the deplorable conditions in the jails. Both Maui and Hawaii facilities are vastly overcrowded. In cells built for two inmates, a third and fourth inmate sleep on small mats on the floor, next to the toilet. It is unconscionable that we have neglected this issue for so long; this is surely a core responsibility and should be a priority. The Department of Public Safety floats plans for alleviating some of the overcrowding, but there needs to be more commitment and follow through.

OTEC has long held the promise of providing affordable, reliable energy production from the temperature difference between warm surface water

and cold, 2000 feet deep water. Creating a durable system that is scalable has been the challenge. In response to my question that pumping water up from the depths seems like the proverbial (impossible) perpetual energy machine, I was told the energy consumed to generate electricity comes from the heat loss of the surface water. The sun warms the water and that heat is converted to electricity.

Another trip I was honored to be part of this year was the 20th Anniversary Celebration of the Hiroshima-Hawaii Sister Statehood relationship. A delegation of senators, representatives, and high school students numbering 135 journeyed to Hiroshima for three days of international exchange in early October. Hiroshima is the ancestral home to more Hawaii residents than any other region of Japan. The vermillion torii near Beretania St and University Ave represents the famous torii on Miyajima Island and it was a gift from the Hiroshima people.

New Cell Phone Tower Planned Near Pupukea Paumalu

Vista Towers ("Vista") recently announced it is willing to consider alternative sites for the proposed 80-foot cell phone tower that was nearly installed directly behind the entrance to Sunset Beach Elementary School.

Many parents were pleased to hear this announcement from Vista Chief Executive Officer, Robert MacLachlan, at the community meeting Vista hosted on Tuesday, October 24th at the Elementary School cafeteria.

Mr. MacLachlan announced that - even though Vista is in a position to continue the construction and already has the tower components stored on site - Vista is voluntarily halting construction in order to help facilitate a community conversation about mutually agreeable alternative sites. The desire is to determine if a location can be agreed upon that can provide much needed cell phone service for AT&T and Verizon customers and that can also address residents' concerns about impacts to cultural, recreational, and visual resources.

Mr. MacLachlan projected that this community process could add up to four to eighteen months to the time needed to erect the tower. When the tower is erected it will provide cellular service as well as internet access.

Vista hosted the community meeting to share information about the cell tower they had begun earthwork on in early October behind the school on the private property of Mr. Lawrence McCully Judd. The entire project area is approximately 2500 square feet and is at an elevation of approximately 115 feet above sea level. These numbers would be roughly the same for any site eventually selected within a half-mile or so of the previous location.

At the meeting and in emails in preparation for the gathering, parents and community members shared several questions and concerns with Vista including, but not limited to: the exact location, height and proximity to the school; proximity to documented Hawaiian cultural landscapes; the technology used and its proposed signal strength; and where the proposed tower will be visible from.

In addition, although several parents asked questions regarding potential health effects of cell phone towers, the Federal government prevents communities from utilizing health concerns to affect the placement of cell phone towers. Moreover, cell phone carriers point to reports from the American Cancer Society and the World Health Organization in order to calm fears the public may have.

In preparation for the community meeting Vista provided much appreciated information. Vista pointed out that there are now over 300,000 cell tower sites in the United States and there are at least 2,000,000 sites throughout the world.

The United States cell phone network began in the 1980s and it now has four major carriers: Verizon, AT&T, T-Mobile, and Sprint. Vista's planned tower will be utilized by AT&T and Verizon.

Vista is a small tower company that specializes in rural facilities. Their mission is to bring coverage to areas that need improved coverage. Vista recently installed a facility at the Polynesian Culture Center ("PCC"). The PCC tower location was selected by BYUH and is about 95-feet tall. The PCC site illustrates the type of facility that will eventually be constructed near Pupukea Paumalu.

MacLachlan explained there will be a number of factors to talk about in discussing alternate sites. The site has to work for coverage for the cell phone carriers and there must be a willing property owner. In addition, regulatory agencies such as the City Department of Planning and Permitting and the State Historic Preservation Division must approve.

The goal is to complete the North Shore's coverage area without leaving a gap requiring additional future sites. That way the selected site will be able to benefit general communications for residents, visitors, and motorists.

In the next several weeks, the North Shore Neighborhood Board ("NSNB"), the Sunset Beach Community Association, and parents/families from Sunset Beach Elementary School will be dialoging about the tower. The community can help Vista move forward and also to get on track with the type of community process the North Shore is accustomed to for significant projects in this region. MacLachlan pointed out that the best thing will be if the community reaches some consensus on an alternate location. Vista will then be able to determine if it will work for the carriers.

Understandably, Vista would also appreciate any NSNB and community support that can be given for any new permits that may be needed for a new location.

Doug Cole of North Shore Community Land Trust is helping facilitate the community process moving forward with Vista and the relevant stakeholders. Vista is committed to working with a small group of stakeholders to attempt to analyze potential alternative locations that meet the criteria discussed above. Vista will present to the NSNB once an alternative site is identified.

Ko'olauloa Health Center welcomes our new doctor, Melissa Ching, who will be providing women's health services (obstetrical and gynecological) at our Kahuku office. She is a graduate of UH at Manoa and the University of Pittsburg School of Medicine in 2007. She completed her internship in Los Angeles and her residency at the University of New Mexico. She will be collaborating with the John Burns School of Medicine, so that deliveries and surgical procedures will be at Kapiolani Hospital.

Dr. Ching is interested in women's health, social issues and animals. This led her to pursue a variety of positions in different settings. While at UH, she worked as a veterinarian technician checking in animals, caring for them, and assisting the vet. She also worked for AmeriCorps as a domestic violence shelter advocate. After graduating from UH, she worked for a non-profit organization in San Diego at an HIV/AIDS clinic and later designed and implemented a high school volunteer program for Head Start. After completing medical school in Pittsburg, she participated in a medical mission to Honduras in 2007. This mission provided medical care in a remote mountain area. She did a second mission in Nepal in 2012 with Aloha Mission where they did surgeries to correct prolapsed uterus (where the uterus has "dropped") in women.

While in medical school, she did a study explaining the increase in the rate of females arrested for intimate partner violence. This led to a residency in OB/GYN. She worked in a private OB/GYN office on Oahu and with Maui Medical Group. Other interests include surfing, running, swimming, yoga, traveling and animals.

Chamber Spotlight – North Shore Chamber Of Commerce Kama'aina Of The Year

The Chamber is pleased to announce that Doug Cole, North Shore Community Land Trust (NSCLT) Executive Director, is this year's North Shore Kama'aina of the Year. He will be honored at their Annual Christmas Party and Auction on December 13th at Waimea Valley. Chamber Board Chair Bill Quinlan remarked that, "We are particularly impressed by the many different areas that Doug has been involved in that have helped the North Shore become a better place to live."

Doug was born on Oahu and raised on the North Shore where he grew up surfing and playing water polo. He attended Sunset Beach Elementary School and Kahuku High School. He then studied at the University of California at San Diego where he graduated in 2000 with a bachelor's degree in history. Immediately after graduation, he returned to North Shore, Oahu. There wasn't another place he'd rather be.

"My childhood was always outside," he says. "Immersed in this beautiful place that is the North Shore, you learn to appreciate the natural environment around you."

His parents, Sally and Peter Cole, instilled in him a commitment to preserve the natural surroundings and cultural heritage which makes the North Shore so unique. As a young boy in the 1980s, Doug remembers how they worked tirelessly to fight development on Pupukea Paumalu, a 1,129-acre parcel overlooking Pipeline, Rocky Point and Sunset Beach. This made a lasting impression of the importance of contributing to community.

When he first returned to Oahu, Doug worked as a substitute teacher and swimming and water polo coach at Kahuku High School. Having previously earned his real estate license, he also honed his skills in real estate sales and property management. Over the years, he volunteered with numerous community organizations including the Sunset Beach Community Association (past president) and the North Shore Neighborhood Board. Since 2008 he's worked at NSCLT, first as its Pupukea Paumalu Project Coordinator, picking up where his parents left off, and then as its first Executive Director. During this time he completed studies at the William S. Richardson School of Law at the University of Hawaii Manoa and passed the Hawaii State Bar Exam. On Nov. 10, 2010, the same day he brought his first

son home from the hospital, Doug was sworn into the bar.

He soon realized that litigation was not for him. "I didn't want to be fighting with everyone," he says. That's what he likes about working with NSCLT. He is able to take a non-adversarial approach and look for "win-win" solutions so that everyone ends up happier. The Pupukea Paumalu Project is an example of that happening, says Doug. Now that acreage is preserved as a park reserve for everyone to enjoy. This was accomplished by bringing many individuals, private groups and public entities together to iron out differences and gather funding.

"It made sense to preserve that property, he says. "Even if we disagreed on how to get there, ultimately we had to agree on getting there. I like to be involved in trying to find those win-win solutions."

Doug through NSCLT has also worked to help preserve Waimea Valley, Sunset Ranch, and more recently over a thousand acres stretching from Kawela Bay to Kahuku Point. In addition, once an area is protected, the work doesn't stop. There are pristine areas to continually preserve; visitor programs to establish, maintain and monitor; and public awareness campaigns and educational programs to develop. These efforts, he says, are to "try to keep the human footprint down" while enabling kama'aina and visitors alike to appreciate and more fully enjoy the gem we know as the North Shore.

However, Doug is a man who is reluctant to take credit. "I don't think I've achieved anything individually," he says. "I've just been fortunate in helping the community achieve great things."



35 Years of Competition, Community and Celebrating Surfing's Heritage By Lauren Rolland

In 1983, Hawaii surfers Randy Rarick and Fred Hemmings, both in their 30's, linked together the three main surf events on Oahu's North Shore to create the very first Hawaiian surfing series. The impetus was to pay homage to Hawaii as ground zero for the sport and determine the best competitive surfer on the North Shore.

The equipment had just shifted from single fins to thrusters and the scaffolding for the Pipe Masters fit in the back of a pickup truck, which took only 1 to 2 hours to assemble. With loose permitting, the Triple Crown was mobile and contest organizers had the freedom to hold events at whichever venue was breaking best along the North Shore, which is why Waimea Bay ran back-to-back in 1985 and '86.

The World Cup at Sunset Beach boasted the largest prize purse professional surfing had ever seen, a hefty \$45,000, and Hawaiians dominated the competition from the start. The Triple Crown was won back and forth between Michael and Derek Ho from 1983 to 1986 with Derek going on to win the title two more times. Dane Kealoha, Buzzy Kerbox and Buttons Kaluhiokalani all finaled in 1983 while Sunny Garcia claimed victory an unprecedented six times.

"We didn't realize at the time what we were establishing in regard to the legacy that was to follow," said Rarick. "The history and the heritage is very significant in the progress of professional surfing."

Thirty-five years later, the Vans Triple Crown of Surfing has evolved into a multi-faceted series that goes beyond world-class surfing in premier waves. The three-prong series involves community-conscious activations, Hawaii's most sustainable event program and a highly-sought after lifestyle that is unique to the North Shore of Oahu.

If the North Shore is the nucleus for professional surfing, then the Vans Triple Crown is mecca for the means.

The Vans Triple Crown of Surfing (VTCS) celebrates 35 years of heritage, competition and collaboration this season and has shaped a thriving cultural breeding ground. Interlacing creative self-expression through action sports, art and music, Vans – one of the industry's original surf/skate lifestyle brands – has remained steadfast in promoting authenticity.

A cornerstone of the North Shore's surf season, VTCS is graciously hosted by the residents and local businesses and in turn, provides a lifestyle that comes full circle; VTCS single-handedly brings \$25 million into the island of Oahu every year by hiring local employees, housing travelling staffers along the North Shore, working with local caterers, vendors and businesses, and granting Hawaii surfers prize money.

This year, the events calendar is chock full of creative activations that include the youth, North Shore community, athletes at-large and fans to showcase surfing in a truly collaborative environment.


